August 2021 Legends Fund 3.00% | YTD 46.04%

Legends Fund Performance

Legends Fund returned +3.00% in August, bringing the year-to-date performance to +46.04%. The reference HFRX Global Hedge Fund Index (EUR) was +0.59% in July and +3.35% year-to-date.

August was a strong month for the Theta Legends fund, with only our most defensively positioned hedge fund, SABA showing negative returns. A relatively calm summer month stayed that way as reopenings continued and economic data remained benign. This led to a strong month for equities, driven by growth stocks and a down month for most fixed income securities. Only high yield and emerging market debt posted positive returns.


The resilience of equity markets, driven primarily by unprecedented monetary and fiscal stimulus, was best exemplified in EM. China continued its regulatory crackdown by expanding punitive policies to for instance the education sector. This led to an initial -4.5% drop in the MSCI EM, but by the end of the month, the index had not only paired back losses, but closed the month at +2.6%.

This backdrop effectively meant that despite a lack of news flow (not uncommon in August), equity long/short, global macro and event driven all performed well. In event driven, Millennium put in a solid +1.23%, while aforementioned SABA was the main detractor, with a -2.39%.

As ever, our investment in blockchain Legend Pantera Capital, warrants a separate mention. After a top 5 sell off in "crypto" in Q2, Pantera continued it's July march upwards, posting a +21% return in August. A notable explosion in the visibility of the non-fungible token (NFT) space is worth mentioning as blockchain technologies start to become more prevalent in consumer use cases.


